The vehicle must be titled in Idaho before it can be registered. The vehicles out of the state, recording for the first time in Idaho, must bring the vehicle to DMV for the VIN inspection. If it is not possible to bring the vehicle to the DMV, you can call shipping to 208-587-2100 for an officer to perform a VIN inspection on the vehicle. It is necessary to provide an Idaho driving license, an Idaho identity card or another photographic ID issued by the state with your social security number or the individual tax identification number (ITIN) business will require an identification number of employees (Ein).
